M-LOK LICENSE

- 1. <u>License Grant</u>. As of the date of later signature below, Magpul Industries Corp. ("Magpul") grants the undersigned Licensee a limited, non-exclusive, non-transferable, royalty-free license, without right to sublicense, to (1) use the Magpul M-LOK System Technical Data Package delivered herewith, including all information contained therein (the "TDP") for Licensee's own internal purposes in developing a Licensee-branded a) firearm accessory mounting surface, b) protective helmet mounting surface, c) compatible accessory(ies) designed to attach to M-LOK surfaces, and/or d) other mounting application, in each case complying with the M-LOK Standard (the "Standard") as described in the TDP (each, a "Licensed Product"), (2) use the M-LOK word and logo marks (the "Marks") solely on or with reference to Licensed Products and solely for the purpose of designating compliance of the Licensed Product with the Standard and (3) practice the inventions claimed by U. S. Patent Nos. 8,925,236, 9,239,209, and 9,239,210 as well as any continuations and foreign counterparts to those patents (the "M-LOK Patents") for purposes of making, using, and selling Licensed Products complying with the Standard.
- 2. <u>Limitations on License</u>. Except for the licenses granted in Section 1, Magpul retains full and exclusive right, title and interest in and to the TDP, the Marks, the M-LOK Patents, and all related patents, trademarks, copyrights and proprietary or trade secret rights. No use of the TDP, Marks, or M-LOK Patents (or of any part thereof) other than expressly authorized by this License is permitted. No right is granted to Licensee to reproduce, distribute, market, or license the TDP (or any part thereof), or to assign any rights hereunder, to third parties, other than the right to allow Certified Vendors (as defined below) manufacturing on behalf of Licensee to use the TDP to manufacture Licensee's products in compliance with the Standard. All uses of the Marks by Licensee and any goodwill generated thereby shall inure solely to Magpul's benefit.
- 3. Export Control Warning. The M-LOK System and TDP are subject to U.S. export control laws and regulations. As part of the express consideration provided for receipt of the M-LOK TDP, the undersigned acknowledges and agrees that it will not export, re-export or otherwise transfer, directly or indirectly, the M-LOK System and TDP or related technical information provided by Magpul in violation of U.S. law, and shall be responsible for obtaining any necessary U.S. government authorization as required to ensure compliance with all applicable laws.
- 4. <u>Confidentiality and Protection of Rights</u>. Licensee agrees to hold the TDP within its own organization and shall not use in any manner, publish, communicate or disclose any part of the TDP to third parties other than employees or subcontractors of Licensee who have a need for such access and who are bound by a written agreement at least as protective as this Section 4 to maintain the secrecy of third party confidential information (each such subcontractor, a "Certified Vendor"). Licensee will take such steps as are consistent with Licensee's protection of its own most sensitive confidential information (but will in no event exercise less than reasonable care) to protect the confidentiality of the TDP. Licensee agrees not to remove or destroy any trademark or copyright notice or confidentiality legends placed upon or contained within the TDP.
- 5. <u>Trademark Usage</u>. Licensee shall use the Marks only in the precise format communicated to Licensee by Magpul from time to time. Licensee shall at all times, and in accordance with any instructions provided by Magpul, make appropriate use of trademark symbols in conjunction with the use of the Marks. Licensee shall not alter, mutilate, dilute, create derivative forms of, or otherwise change the format of the Marks in any way. Without limiting the foregoing, Licensee shall not use the Marks with Licensee's or any third party's marks in such a way so as to create a composite mark. Licensee warrants that the Licensed Products offered under the Marks will be at a level of quality that reflects positively on the M-LOK system and M-LOK brand in the judgment of the Licensor. At Magpul's request, Licensee will provide Magpul with reasonable information regarding its Licensed Products, including without limitation, samples of use of the Marks on the Licensed Products and dates of first use of the Marks on the Products, to enable Magpul to protect its Marks.
- 6. <u>Patent Marking</u>. Licensee shall give notice to the public that Licensed Product is subject to patent protection by fixing "Patent https://www.magpul.com/ip" on all Licensed Product or, if this cannot be done given the size or shape of the product, by placing this information on the product's packaging.
- 7. <u>Disclaimer of Warranties; Limitation of Liability</u>. THE TDP AND THE MARKS ARE PROVIDED "AS IS." MAGPUL DISCLAIMS ALL WARRANTIES, EXPRESS, IMPLIED OR STATUTORY, AS TO ANY MATTER WHATSOEVER, INCLUDING ALL WARRANTIES OF PERFORMANCE, MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE AND NON-INFRINGEMENT OF THIRD PARTY RIGHTS. MAGPUL SHALL HAVE NO RESPONSIBILITY TO PROVIDE LICENSEE WITH ANY TRAINING, TECHNICAL SUPPORT,

MAGPUL SHALL NOT BE LIABLE OR OBLIGATED FOR ANY LOSS OF USE, INTERRUPTION OF BUSINESS, OR ANY DIRECT, INDIRECT, SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES OF ANY KIND, WHETHER IN CONTRACT, TORT, NEGLIGENCE, STRICT PRODUCT LIABILITY, OR OTHERWISE, EVEN IF MAGPUL HAS BEEN INFORMED OF THE POSSIBILITY IN ADVANCE. - 8. <u>Termination</u>. Magpul shall be entitled to terminate the license rights granted hereunder at any time on written notice to Licensee. Upon termination, Licensee shall cease using the TDP and Marks with regard to any products not then in production. Licensee shall immediately return to Magpul or certify to Magpul that it has destroyed all copies (including all copies stored in computer memory) of the TDP and all other information and documentation provided by Magpul to Licensee.
- 9. <u>Miscellaneous</u>. This Agreement shall be binding upon and inure to the benefit of the parties and their respective successors and permitted assigns. Neither this Agreement nor any of the rights or obligations of Licensee hereunder may be assigned or delegated without the prior written consent of Magpul. This Agreement, including the attached M-LOK Licensing Contact and Licensed Product Information Sheet "Cover Sheet"), and any subsequent Cover Sheets submitted by Licensee to Magpul, sets forth the entire agreement and understanding between the parties as to its subject matter and supersedes all prior discussions and agreements, oral or written. This Agreement shall be construed in accordance with and governed by the laws of the State of Texas. Any term or provision of this Agreement may be amended, and the observance of any term of this Agreement may be waived, only by a writing signed by the parties. The provisions of the Agreement are severable, and if any provision is held to be invalid or unenforceable, such provision shall be stricken from the Agreement, and the balance of this Agreement shall have its intended full force and effect.
